

# Privacy policy

We are committed to protecting the privacy of the personal information you provide us on our website (the "oceanplazasouthport.com/"). This policy (together with our terms and conditions and any other documents referred to on it) sets out the basis upon which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. # **Collection of information**

We may collect and process the following data about you:

Information you give us. You may give us information about you by filling in forms on our Website or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when registering to use our Website, subscribing to our service, posting material or requesting further services. We may also ask you for information when you enter a competition or promotion sponsored by us, our partners, retailers or other organisations we have a relationship with and when you report a problem with our Website. In addition, we may collect and process information provided by you on publicly accessible areas of third party websites. We do not sell your Personal Information. In the case of actions listed above, you will be able to 'unsubscribe' from these at any time. It is completely optional for you to register, participate or otherwise provide us with Personal Information in the above situations.

Information we collect about you. With regard to each of your visits to our Website we may automatically collect the following information:

technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;

information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our Website (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information



(such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any phone number used to call our customer service number.

Information we receive from other sources. We may receive information about you if you use any of the other websites we operate or other services we provide. We are also working closely with third parties and may receive information about you from them.

## Use of information

We will use the information you give us:

to provide you with information, products and services that you request from us;

to provide you with information about other goods and services we offer that are similar to those you have already enquired about;

to provide you, or permit selected third parties to provide you, with information about goods or services we feel may interest you;

to notify you about changes to our service; and

to ensure that content from our Website is presented in the most effective manner for you and your computer.

We will use the information we collect about you:

to administer our Website and for internal operations, including troubleshooting, data analysis, testing and research;

to allow you to participate in interactive features of our service, when you choose to do so;

as part of our efforts to keep our Website safe and secure; and



to measure or understand the effectiveness of advertising we serve to you and others and to deliver relevant advertising to you.

We may disclose your Personal Information to any member of our group, retailers we partner with or selected companies acting on or behalf. We will only share your Personal Information to other parties as required by law or to protect customers or the public. If the shopping centre/retail park to which this Website relates (or the owner of that shopping centre/retail park) is acquired by a third party, we may transfer your personal data to the buyer.

## Where we store your personal data

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers. Such staff may be engaged in, among other things, the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.
